ORDER

As per the representation read as 1st paper above, Shri.Kamalasanan N., Saroj Vihar, Eranjippalam P.O Kozhikode-6 had offered to part with 33.80 ares of land and building possessed by him at Veliyam Village in Kollam district free of cost for establishing care home for mentally challenged women .

As per the letter read as 2nd above, the Director, Social Justice Department had recommended to take over possession of the land and building of Shri.Kamalasanan.

Government have examined the matter in detail and are pleased to accord sanction to the Director, Social Justice Department to immediately take over possession of 33.80 ares of land and building (H No.7/439) in Re-Survey No 463/3, block No.30 at Veliyam Village in Kollam district possessed by Shri.Kamalasanan N. free of cost for the establishment of a care home for mentally challenged women with the following conditions:-

- 1) The name of the institution shall be ' Priya Home for Mentally Challenged women' fully owned and operated by Government of Kerala.
- 2) Kum.Priya, daughter of Shri.Kamalasanan will be provided all facilities for her stay and food in the institution during her life time if Shri.Kamalasanan or his wife desires so.
- 3) A Co-ordination committee comprising District Social Justice officer as convenor, Tahsildar, Panchayat President, ICDS Supervisor, ward member and one representative of Shri.Kamalasanan will be formed for overseeing the day to day functioning of the institution.




- 4) An undertaking shall be obtained from Shri.Kamalasanan, before the take over, that he will not interfere in the day to day running of the institution and all decisions in the running of such home will be taken by department of Social Justice or Government from time to time. It will be run purely as a government institution once it is taken over and the representative of Shri.Kamalasanan may raise his concerns in the Co-ordination committee, if any deviation is found from the conditions agreed upon. If it is not redressed in the committee, it shall be referred to the District Social Justice Officer first and then to the Secretary, Social Justice Department and the Secretary's decision shall be final in the matter.
- 5) The District Collector, Kollam will make arrangement of preparation of a mahazar during the taking over of building, property, trees standing thereon etc as per rules.
- 6) The Director, Social Justice Department will make arrangements to undertake minimum improvements within a period of one month and make the home operational at the earliest and post necessary staff to establish a home for Intellectually challenged girls and women.
- 7) Meanwhile, the District Collector, Kollam will complete all procedures required for taking over the land and building and to convert it as a Government property.
